

## **“Ultimate Banff Springs Golf Experience powered by Journie Rewards” Contest**

The Ultimate Banff Springs Golf Experience powered by Journie Rewards (the “Contest”), sponsored by the Royal Canadian Golf Association operating as and hereby, “Golf Canada,” commences at 9:00am ET on August 21, 2023 and concludes at 11:59 pm ET on September 18, 2023 (the “Contest Period”).

How to Enter:

1. Visit [www.journiebanffgolfexperience.com](http://www.journiebanffgolfexperience.com) to complete and submit the contest form.
2. No purchase necessary.

The Contest is open to all residents of Canada (including the province of Quebec) who are 18 years of age or older at time of entry, except for employees of Golf Canada, employees of their Provincial Associations, affiliates advertising or promotional agencies, or members of those persons' respective immediate families, or anyone with whom any of those persons are domiciled.
